#### **Charges and Billing**

Market Data charges of £350 per month are payable for Market Data based on each Non-Display Application, per Market Datafeed site.

Billing frequency is annually in advance and will commence on 1 July 2023. New customers will be charged pro rata

#### **Reporting per Non-Display Application**

The existing data vendor customer shall complete and submit to Baltic the initial declaration before 1 June 2023. Subsequent declarations will be submitted annually by 1 July. New customers must complete the declaration prior to receiving the datafeed. The customer shall use its best endeavors to ensure the completeness and accuracy of all the information contained in each report
